**ION Platform Investment Group Limited**

**Proposed offering of approximately \$2.6 billion (equivalent) Senior Secured Notes**

ION Platform Investment Group Limited (“**ION Platform**”), through its subsidiaries ION Platform Finance US, Inc. and ION Platform Finance S.à r.l. (the “**Issuers**”) announced today that it intends to issue and offer approximately \$2.6 billion (equivalent) aggregate principal amount of senior secured notes, consisting of U.S. dollar-denominated notes expected to mature in 2032, and euro-denominated notes expected to mature in 2030 and 2032 (the “**Notes**”), subject to market conditions and demand (the “**Offering**”). The proceeds from the Offering, together with the proceeds of a new credit facility, will be used (i) to fully repay amounts outstanding under existing term loans, (ii) to pay fees and expenses incurred in connection with the transactions, and (iii) as cash on balance sheet for general corporate purposes. The Offering is part of ION Group’s recent strategic consolidation and ongoing refinancing initiative of ION Platform, as previously announced in the press release dated September 18, 2025.
